4. DISCUSSION AND CONSIDERATION TO ADOPT THE PROPOSED ROSTER FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAMS FOR FISCAL YEAR 2020-2021

RECOMMENDED ACTION: At the conclusion of the Public Hearing, adopt the proposed roster for Community Development Block Grant (CDBG) programs for Fiscal Year 2020-2021.

Administrative Analyst Knighton presented her report stating that in order to receive Community Development Block Grant funds, Lomita is required to maintain an agreement with the Los Angeles County Development Authority (LACDA), and submit an annual program budget roster.

With an estimated total budget of \$147,439, staff recommends the board adopt the proposed FY 2020 - 2021 CDBG program roster, which includes:

- \$ 45,000 Job Creation and Business Incentive Loan Program
- \$ 72,952 Residential Rehabilitation Program
- \$ 29,487 Lifeline Personal Response System

Given the success with the Job Creation and Business Incentive Program since the City launched it two years ago, additional funds are shifted to the Program in the proposed budget from the Residential Rehabilitation Program.

Any future modification to the final CDBG allocation will be applied to the Residential Rehabilitation program.

Chair Gazeley opened the public hearing at 5:35 p.m. for comments and questions from the public. There being no comments or questions from the public, Chair Gazeley closed the public comment portion of the public hearing and brought the item back to Council for discussion and vote.

In response to a question from Board Member Sanchez, Assistant City Manager Sugano stated that the difference in the program roster from the amounts presented last fiscal year was due to monies that were received last year that were issued to the City on a one-time basis.

Board Member Savidan made a motion, seconded by Vice-Chair Waronek to close the public hearing and adopt the proposed roster for Community Development Block Grant (CDBG) programs for Fiscal Year 2020-2021.

RECOMMENDATION

At the conclusion of the Public Hearing, adopt the proposed roster for Community Development Block Grant (CDBG) programs for Fiscal Year 2021-2022.

BACKGROUND

In 1974, the U.S. Congress introduced the Community Development Block Grant (CDBG) Program as part of the Housing and Community Development Act. CDBG is funded by the U.S. Department of Housing and Urban Development (HUD). Although the Act has been amended in recent years, the primary objective continues to be developing viable urban communities by providing decent housing, a suitable living environment, and expanding economic opportunities, principally for low- and moderate-income persons.

The Los Angeles County Development Authority (LACDA), formerly the Los Angeles County Community Development Commission administers this funding on behalf of the Los Angeles County Board of Supervisors, which oversees the LACDA, and 48 participating cities throughout the County including Lomita.

FY 21-22 Funding

Community Development Block Grant funding is offered by the US Department of Housing & Urban Development (HUD), and because Lomita's population is under 50,000, Lomita is required to maintain an agreement with Los Angeles County Development Authority (LACDA) in order to receive CDBG funds though the HUD-administered Small Cities program.

The CDBG allocation formula is based upon the City's demographic characteristics such as the low to moderate income population and the total amount of CDBG funds granted to LACDA. The annual funding amounts have been relatively stable over the past several years.

The estimated allocation amount of \$150,666 is reported by HUD. It is not unusual for HUD to revise the allocation again, and any modification that increases or decreases the final allocation will be applied to the Residential Rehabilitation program.

The proposed total budget is \$150,666.

Use of HUD's CDBG Allocation for FY 2021-2022

- 1. Residential Rehabilitation Program serving single-family homes throughout the City. At the time of this report, the program currently has a waiting list of 81 applicants waiting to be mailed applications. The program will expect to assist approximately 12 participants during FY 2021-2022.
- 2. The Lifeline Personal Response System has ongoing clients that receive medic alert assistance, carrying a maximum of 26 clients on an annual basis.
- The Job Creation and Business Incentive Loan Program is a continuing program that will provide forgivable loans to businesses in the City for the purpose of creating permanent jobs that will be made available to low and moderate income individuals.

<u>Implementation Process:</u>

Participating cities are required to adopt and submit program budget documents based on the anticipated fiscal year allocation and unallocated balance (estimated total \$150,666). Therefore, below are the program budgets for the estimated FY 2021-2022 allocation (1).

(1) CDBG FY 21-22 Program Budgets as of July 1, 2021: \$150,666.

Residential Rehabilitation Program: \$30,533 Lifeline Personal Response System: \$30,133

Job Creation and

Business Incentive Loan Program: \$ 90,000
