The Lomita Planning Commission will hold a public hearing at 6:00 p.m. or as soon thereafter as the matter may be heard on Monday, October 11, 2021, to consider the following:

<u>Vesting Tentative Parcel Map</u>: A request to subdivide an existing 19,148 square-foot single family residential lot into two single-family lots and to confirm the categorical exemption, located at 25307 Oak Street, in the R-1, Single-Family Residential Zone. <u>Site Plan Review:</u> A request for a Site Plan Review to allow beauty shop uses to occupy more than 30 percent of the ground floor area of an existing multi-story commercial building and to confirm the categorical exemption at 25820 Lucille Avenue, in the C-R (Commercial Retail) Zone. Pursuant to Lomita Municipal Code 11-1.48.03(B), beauty shops are a permissible use in the C-R Zone but are subject to Planning Commission review if the ground floor area occupied by the use exceeds 30 percent of the total ground floor area.
