RECOMMENDED ACTION: At the conclusion of the Public Hearing, adopt the proposed roster for Community Development Block Grant (CDBG) programs for Fiscal Year 2021-2022.

Analyst Contreras presented the item per the agenda material, giving an overview of the CDBG funding and objectives.

Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) funds are administered through the Los Angeles County Development Authority (LACDA) (formerly called the CDC) on behalf of the Los Angeles County Board of Supervisors to 48 participating cities throughout the County including Lomita.

The primary objective of the CDBG is to develop viable urban communities by providing decent housing, a suitable living environment, and expanding economic opportunities, principally for low and moderate-income persons. The Residential Rehabilitation Program provides grants to low-income residents to rehabilitate their homes. The program will expect to assist approximately 12 participants during FY 2021-2022. The Lifeline Personal Response System (typically referred to as simply Lifeline) provides participants a medic alert system with small transmitter that when pressed summons immediate medical assistance on a 24-hour basis. The program carries a maximum of 26 clients on an annual basis. The Job Creation and Business Incentive Loan Program (typically referred to as JCBI) is a continuing program that will provide forgivable loans to businesses in the City for the purpose of creating permanent jobs that will be made available to low-income individuals.

The estimated CDBG allocation amount for Fiscal Year 2021-2022 reported by HUD is \$150,666. The CDBG allocation formula is based upon demographic characteristics and the total amount of CDBG funds granted to the LACDA. The annual funding amounts have been relatively stable over the past several years. Any modification that increases or decreases the final allocation will be applied to the Residential Rehabilitation Program.

The Proposed CDBG Program Budget Roster for 2021-2022 utilizes the Total FY 2021-2022 allocation of \$150,666; as follows:

Residential Rehabilitation Program \$30,533.

Lifeline Personal Response System \$30,133.

Job Creation & Business Incentive Loan Program \$90,000.

Staff recommends that at the conclusion of the Public Hearing, the Commission adopts the proposed budget roster for Community Development Block Grant (CDBG) programs for Fiscal Year 2021-2022.

RECOMMENDATION

At the conclusion of the Public Hearing, adopt the proposed roster for Community Development Block Grant (CDBG) programs for Fiscal Year 2022-2023.

BACKGROUND

In 1974, the U.S. Congress introduced the Community Development Block Grant (CDBG) Program as part of the Housing and Community Development Act. CDBG is funded by the U.S. Department of Housing and Urban Development (HUD). Although the Act has been amended in recent years, the primary objective continues to be developing viable urban communities by providing decent housing, a suitable living environment, and expanding economic opportunities, principally for low and moderate income persons.

The Los Angeles County Development Authority (LACDA), formerly the Los Angeles County Community Development Commission administers this funding on behalf of the Los Angeles County Board of Supervisors, which oversees the LACDA. 48 participating and cities throughout the County including Lomita.

FY 22-23 Funding

Community Development Block Grant funding is offered by the US Department of Housing & Urban Development (HUD), and because Lomita's population is under 50,000, Lomita is required to maintain an agreement with Los Angeles County Development Authority (LACDA) in order to receive CDBG funds though the HUD-administered Small Cities program.

The CDBG allocation formula is based upon the City's demographic characteristics such as the low to moderate income population and the total amount of CDBG funds granted to LACDA. The annual funding amounts have been relatively stable over the past several years.

The estimated allocation amount of \$148,379 is reported by HUD. It is not unusual for HUD to revise the allocation again, and any modification that increases or decreases the final allocation will be applied to the Residential Rehabilitation program.

The proposed total budget is \$148,379

The Public Service Cap for FY 2022-23 is 15% of the estimated allocation, decreasing the Lifeline Personal Response System budget for FY 2022-23.

Use of HUD's CDBG Allocation for FY 2022-2023

- 1. Residential Rehabilitation Program serving single-family homes throughout the City. At the time of this report, the program currently has a waiting list of 90 applicants waiting to be mailed applications. The program is expected to assist approximately 5 participants during FY 2022-2023.
- 2. The Lifeline Personal Response System has ongoing clients that receive medic alert assistance, carrying a maximum of 20 clients on an annual basis.
- The Job Creation and Business Incentive Loan Program is a continuing program that will provide forgivable loans to businesses in the City for the purpose of creating permanent jobs that will be made available to low and moderate income individuals.

Implementation Process:

Participating cities are required to adopt and submit program budget documents based on the anticipated fiscal year allocation and unallocated balance (estimated total \$148,379). Therefore, below are the program budgets for the estimated FY 2022-2023 allocation (1).

(1) CDBG FY 22-23 Program Budgets as of July 1, 2022: \$148,379.

Residential Rehabilitation Program: \$30,000 Lifeline Personal Response System: \$22,256

Job Creation and

Business Incentive Loan Program: \$ 96,123

(SBG) Program

RECOMMENDATION

At the conclusion of the Public Hearing, allocate Community Development Block Grant (CDBG) funds in the amount of \$175,442 for the Small Business Grant (SBG) Program managed by the LACDA and direct the City Manager to take the necessary steps to implement.

BACKGROUND

Community Development Block Grant funding is offered by the US Department of Housing & Urban Development (HUD), and because Lomita's population is under 50,000, Lomita is required to maintain an agreement with Los Angeles County Development Authority (LACDA) in order to receive CDBG funds though the HUD-administered Small Cities program.

The City has received CDBG funds for many years and has built up an unallocated balance through carryover funds from prior years.

The Small Business Grant (SBG) Program would assist local business that have been economically impacted by the COVID-19 pandemic. The SBG will provide grants of \$10,000 to eligible businesses located in the City of Lomita that create or retain job(s) for low and moderate income people. If approved, the SBG program would be managed by LACDA staff which would include receiving application submittals, review, award and implementation of each grant.

As you know, Lomita's small business community has had its challenges navigating during the Covid-19 pandemic and this program will supplement the City's existing American Rescue Plan (ARP) Small Business Assistance Program.

The City of Lomita Community Development Block Grant has \$175,442 in unallocated CDBG funds. It is recommended that the City use these unallocated funds to participate in the Los Angeles County Development Authority (LACDA) Small Business Grant program. As was previously mentioned, by participating in this program, the City will have a minimal administrative burden while being able to provide additional financial assistance to small businesses in Lomita.

It is recommended that the \$175,442 in unallocated CDBG funds be allocated to the following project:

LACDA Small Business Grant Program \$175,442. (Would provide approximately 17 grants for eligible small businesses in Lomita)

Program Guidelines

Eligible Businesses

Small Businesses located in Lomita and meet the criteria below:

- Small Businesses with less than 500 employees that have been impacted by COVID-19
- Restaurants, coffee shops, bakeries, cafés, gastropubs, salons, barbers and other grooming businesses, gyms, day spas, and fitness studios
- Retail and commercial stores such as local markets, consumer goods, electronics, appliances, health and sporting goods, furniture, clothing and shoes, books, and music stores
- Active business license in the City or County, as applicable
- No unresolved City, municipal, or health code violations
- · Business in continuous operation in our City for at least two years

Use of Grant Funds:

Grant funds can be used for operational business expenses such as:

- Employee payroll
- Working capital to continue operations
- Payment of outstanding business expenses
- Adaptive practices needed to remain open (i.e. equipment and supplies for physical distancing)

Participation and Award:

Eligible businesses would submit an intake form during the 5-day open application period (Date TBD). After the intake period closes, a lottery will be conducted and selected businesses will be requested to complete an application. The Los Angeles County Development Authority (LACDA) will work with the selected businesses on behalf of the

City of Lomita to complete an application, execute an agreement, and provide the grant funds directly to the business owners.
