Frances Marshall, a Lomita resident, stated opposition to what she called draconian measures in response to the water shortage.

Council Member Waronek asked City Manager Smoot to reach out to Cal Water to make sure the City's water shortage recommendations are consistent with theirs.

Scott Marshall, a Lomita resident, stated that more reservoirs are needed, and water desalination plants should be considered, to make the lives of Californians more comfortable.

There being no other comments or questions from the public, Mayor Segawa brought the item back to Council for a motion.

Myrna Shahaday, Lomita resident, had questions regarding the City's use of Covid-19-related relief funds. She also asked the status of the space next to the Lomita Railroad Museum.

City Manager Smoot gave clarification of the funds the City has received related to ARPA funds and how they are projected to be used and gave updates on future plans of the area near the Railroad Museum.

George Kivett, a Lomita resident, expressed his confidence in the Council's handling of the budget.

Michelle Race asked where the COLA is categorized in the budget.

City Manager Smoot stated that while negotiations continue, eventually the Council will consider a Memorandum of Understanding (MOU) relative to COLA. When approved, resolutions will be created which show the salary adjustments due to COLA, and this data will be incorporated into the budget.

As there were no further requests from the public to speak on this item, Mayor Segawa closed the public hearing at 7:42 p.m. and brought the item back to Council for a motion.
